## 40 Years Later: Operation Fuel's Services More Vital Than Ever

Governor Ella Grasso started Operation Fuel in 1977 as a temporary energy assistance program to help Connecticut households through what was expected to be a short-term crisis.

Now 40 years later, the energy program is more vital than ever. Since 1977, Operation Fuel has helped more than 150,000 vulnerable households by providing over \$46 million in energy assistance.

Operation Fuel has grown into a statewide, year-round energy assistance program with more than 100 fuel banks throughout Connecticut. Besides providing energy assistance to thousands of Connecticut households each year, Operation Fuel is making a difference in other key areas. Some important initiatives include:

- Creating a program in 2013 to prevent and reduce homelessness. Since its inception, the program has granted \$134,303 in energy assistance to 210 applicants.
- Establishing a small business energy efficiency program and several pilot programs promoting energy efficiency and renewable energy in the residential sector.
- Developing a pilot program that offers financial assistance toward the repair or replacement of inoperable boilers and furnaces.

For more than 10 years, Operation Fuel and its staff have helped to educate its community partners about the impact that the high cost of energy has on poverty while offering potential strategies for change. During this time, Operation Fuel has become the voice for families and individuals who are struggling with unaffordable energy bills, and has brought attention to the energy affordability crisis that currently



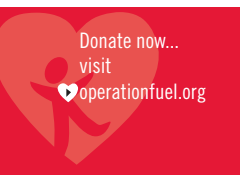

affects more than 322,000 Connecticut households.

There is now a \$399 million energy affordability gap for state households with incomes at or below 200 percent of the Federal Poverty Level, according to Operation Fuel's latest Home Energy Affordability Gap report for the state of Connecticut. The affordability gap is the portion of their energy bills that 322,000 Connecticut households can't afford to pay, not the entire amount that they owe.

Although the gap declined by nearly \$71 million from \$470 million in 2015, this drop was due primarily to a reduction in the price of home heating oil and natural gas over the past year. About 9,000 more Connecticut households can't afford their energy bills compared with 313,000 the previous year. On average, each of the

## A Word from The Executive Director



Dear Friends,

As Operation Fuel observes its 40th anniversary, it is a good time to reflect on what we have accomplished over the years.

We started as a temporary winter energy assistance program in 1977 when an oil embargo drove up the price of heating oil. After the embargo ended, energy costs continued to rise and families who were between 150% and 200% of the federal poverty level still had no place to get help if they fell behind on their energy bills.

Thanks to the generosity and support of each of you, we have been able to achieve much more than we ever could have imagined that first winter. Since 1977, we have helped more than 150,000 households with over \$46 million in energy grants. Many of these households were extremely vulnerable and included children, the elderly, and people with chronic illnesses.

Over the past several years, we have evolved into a year-round energy assistance program. As often happens, this winter began mildly and then the snow and frigid temperatures arrived. Through late February, we have provided \$622,700 in winter energy assistance to 1,401 households.

We know this amount will increase before the winter ends. Then we will prepare for our summer program, which assists low-income households with their electricity bills and helps them to avoid the dangerous health impacts of the heat.

After nine months as Executive Director of Operation Fuel, I am very grateful for the hard work of our wonderful staff, the invaluable community partners at our fuel banks, and the consistent support of our donors and funders. It is an honor to be a part of this team!

## Operation Fuel and Utility Companies Host Annual Energy Assistance Conference

As part of its preparation for the 2016-2017 winter energy assistance program, Operation Fuel held its annual Energy Assistance Conference on October 12 in partnership with Eversource Energy, The United Illuminating Company, Southern Connecticut Gas and Connecticut Natural Gas. Along with staff from Operation Fuel and from the utilities, fuel banks from throughout Connecticut and representatives from several state agencies attended.

The conference focused on the availability of energy assistance and various programs that the utility companies have to help lower-income households manage their energy expenses during the winter.

In particular, fuel bank staff were advised to encourage their clients to participate in the Home Energy Solutions™ (HES-IE) Income-Eligible program, which is offered free of charge to households that qualify, and helps to lower energy bills and makes energy assistance grants go further.

Another way to help keep down energy expenses, which was discussed during the meeting, is to carefully choose an

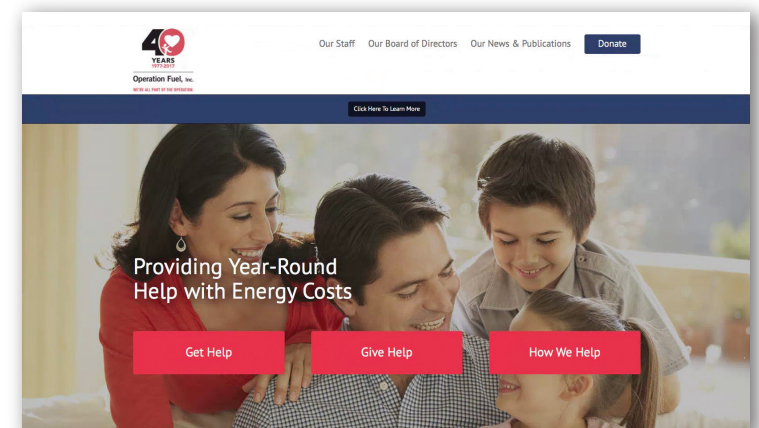
electric supplier and compare the rates being offered. For more information on energy suppliers, visit <http://www.energizect.com/compare-energy-suppliers>.

“We want to make sure that every vulnerable Connecticut household gets the help they need. Families and individuals with low and fixed incomes often have difficulty keeping up with the expense of heating their homes and still being able to afford food, medicine and other basic needs,” pointed out Brenda Watson, Operation Fuel’s Director of Community Programs.

## Shoreline Fuel Bank Seeing More Need From People Over 50

The Pawcatuck Neighborhood Center (PNC) has been seeing an increased need for energy assistance from people who are 50 and older, according to PNC's Executive Director Vicki Anderson.

She said many of the people in this age group, who are asking PNC for help paying their energy bills, have lost their jobs and are struggling financially. Other applicants, Anderson added, have had their full-time jobs reduced to part-time.

PNC has been part of Operation Fuel's statewide network of fuel banks for the past 14 years. Through PNC, Operation Fuel provides energy assistance to families and individuals in North Stonington and Stonington, which includes Pawcatuck.

Anderson, who will retire on June 30 after 15 years as PNC's executive director, said that over the years Operation Fuel has been one of her agency's most reliable sources for

energy assistance. She especially appreciates that Operation Fuel will help households that use all types of energy including propane and wood.

"Operation Fuel has guidelines and follows them, but they thoroughly understand that life is full of special circumstances. When we call with a special request, the staff listens to why we believe someone's needs are unusual. Operation Fuel is always easy to reach, responsive and caring," said Anderson.

So far this fiscal year, Operation Fuel has given out \$3,302 in energy assistance to PNC for nine households. The previous fiscal year, Operation Fuel provided PNC with \$7,596 for 23 households.

PNC also provides energy assistance through both the Connecticut Energy Assistance Program and the United Way's Project Warm-Up and from donations made directly to its agency.

Anderson said that she expects there will continue to be an increased need for energy assistance from people who are over 50. "They're finding it difficult to find a new job, especially one that will cover their expenses. And now they are using up their savings, which can create more problems in the future. Some are having medical problems that are causing unexpected expenses, as well as the inability to work right away. It's a perfect storm of events," added Anderson.

## With 106 Fuel Banks, Operation Fuel Continues to Expand its Ability to Offer Energy Assistance to Struggling Households

Operation Fuel's partnership with its fuel banks has always been a major factor in the success of the nonprofit energy assistance program. Operation Fuel has grown from approximately 30 fuel banks when it began in 1977 to a current statewide network of 106 fuel banks.

Fuel banks are part of community agencies, municipal human and social service departments, and religious organizations. "Without our fuel banks and their dedicated staff, many

vulnerable families and individuals would not have access to Operation Fuel's services," explains Brenda Watson, Operation Fuel's Director of Community Programs.

Since the beginning of this fiscal year, several new fuel banks have become part of Operation Fuel. Among them are Hands On Hartford, New Vision International Ministries of Bridgeport, Conn., Norwich Public Utilities, and Operation Hope in Fairfield, Conn.

## Hands On Hartford

Executive Director Barbara Shaw said Hands On Hartford is happy to once again be a fuel bank for Operation Fuel. Hands On Hartford began in 1969 as Center City Churches and served as one of Operation Fuel's volunteer fuel banks from 1989 to 2004, helping thousands of households with their heating bills.

Now that Hands On Hartford has moved to a larger office, they will be able to handle the high number of energy assistance requests, said Shaw adding, "being part of the Operation Fuel network allows us to increase our direct need assistance."

She said one out of three households in Hartford live below the federal poverty level and are forced to make difficult decisions about which bills to pay with their limited income, including rent, a medical bill, transportation, food, or their utilities.

Hands On Hartford recently helped Mary, a single mother with a 19-year-old daughter who has a disability. After Mary lost her job in November, she started to fall behind on her electric bill.

She received a shut-off notice in early February, when her bill reached nearly \$400. Although she was frantically looking for work, she could not find anything. She contacted Hands On Hartford and qualified for an energy assistance grant from Operation Fuel, which paid her entire bill. Mary also signed up for Hands On Hartford's Community Pantry where she can shop for staples and fresh foods to help her until she finds a new job and is back on her feet.



## New Vision International Ministries

New Vision International Ministries of Bridgeport, Conn. had been referring households to Operation Fuel for several years before it became a fuel bank this past summer. Since then, the new fuel bank has provided energy assistance from Operation Fuel to 14 households.

Becoming a fuel bank was a natural transition for the church. In the past, “New Vision received numerous requests for utility assistance and oil delivery payment help from church members as well as from families in the surrounding communities,” said Project Coordinator Paula Britt-Moody.

Britt-Moody runs the fuel bank with Anthony Moody, Business Empowerment Services, and Patricia Hidalgo, who is also a Project Coordinator. Hidalgo previously had worked at a local social service agency where one of her responsibilities was working with Operation Fuel’s energy assistance program.

The fuel bank recently helped a family of eight who needed an oil delivery. “We were able to complete the application, provide documents to Operation Fuel and act as a liaison between the applicant and the oil company to grant this family with a same day delivery. We also were able to provide emergency information and referral services to the family,” said Britt-Moody.

## Norwich Public Utilities

In November, Norwich Public Utilities (NPU) became the first Connecticut utility to also operate as a fuel bank when two NPU customer service representatives were trained to take applications for Operation Fuel. Customer Service Manager Ruth Swift said that NPU decided to become a fuel bank after its local social service agency, Norwich Human Services, had to reduce its staff due to budget cuts. “Brenda Watson and I worked together to establish NPU as a fuel bank so our residents would still have a local resource for assistance from Operation Fuel,” explained Swift.

So far it has been a slow start but Swift thinks that will change when the winter moratorium ends and customers realize

that NPU can submit applications to Operation Fuel for energy assistance.

“I am very grateful that Brenda agreed to work “outside of the box” and help NPU become a fuel bank for Operation Fuel. I am looking forward to a long relationship with Operation Fuel,” said Swift.

## Operation Hope

Operation Fuel and its Homeless Intervention and Prevention Program (HIPP) match up well with Operation Hope’s mission. The Fairfield nonprofit became a fuel bank and part of Operation Fuel’s HIPP in September 2016.

Besides addressing the basic need for food and shelter, Operation Hope offers long-term solutions to hunger and homelessness including affordable housing. “Operation Fuel fits into our mission by providing the extra financial assistance needed to provide emergency energy assistance to prevent homelessness and provide assistance for a household’s past utility arrearage,” explained Operation Hope’s Executive Director Carla Miklos.

As of mid-February, seven Fairfield households had received energy assistance from Operation Fuel. One recipient was a couple who are both disabled and living on a fixed income.

The family was struggling to make ends meet and had a shut-off notice for their electricity, which was their source of heat. While the couple could pay the current bill each month, they

couldn’t afford the past due amount. Operation Fuel’s grant helped them maintain their electricity and heat during the coldest time of the year.

322,000 households owes about \$1,241 more in annual energy bills than they can afford to pay.

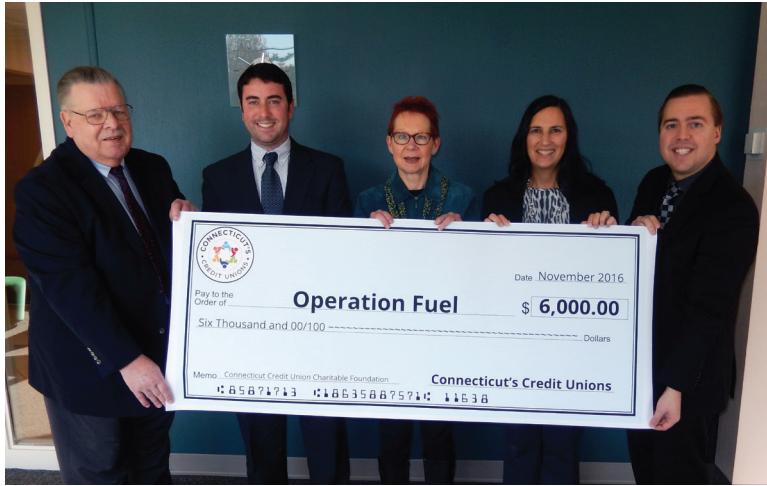
In response to the increased need, Operation Fuel’s network of fuel banks has grown from about 30 in 1977 to 106 current fuel bank sites throughout Connecticut, greatly expanding its ability to offer energy assistance to struggling families and individuals.

Through late February, Operation Fuel had provided \$622,700 in winter energy assistance to 1,401 households. Since the fiscal year

began on July 1, 2016, Operation Fuel has awarded more than \$1.8 million in energy assistance grants to 4,323 households. This includes over \$1.2 million to 2,922 households during the summer of 2016.

Operation Fuel’s staff has begun preparing for the upcoming spring and summer months, when lower-income families and individuals are in danger of losing their electricity or gas services because they can’t afford the high cost of energy. The annual winter moratorium, which prevents households from having their utilities shut off, ends on May 1, 2017 and won’t resume until November 1, 2017.

## New London Event Puts Homeowners on Path to Lower Energy Costs Through Conservation

Saving money through energy conservation was the central theme of several workshops that Operation Fuel convened in New London this winter. More than 30 homeowners participated in the workshops that highlighted a range of strategies for managing energy costs. Operation Fuel organized the workshops as part of a pilot project with the Connecticut Green Bank, testing ways to encourage conservation among energy assistance clients. The workshops featured presenters from multiple service providers and connected participants to the services and programs most suitable for their specific situations.

The Access Agency, based in Willimantic, covered weatherization and energy efficiency programs that make improvements in homes resulting in reduced energy consumption. The Access Agency can draw from multiple funding sources to assemble the most favorable package of energy efficiency measures for a given home, and maximize incentives and rebates.

Posigen, the Connecticut Green Bank's solar energy provider, presented their Solar For All option. The Posigen solar option is designed to be accessible to homeowners at a broad range of income levels, offering solar panels for single family homes with no down-payment or credit check at an affordable monthly rate, which is fixed for 20 years. Importantly, energy efficiency measures are put in place before installing solar panels on any participating homes.

Community Development staff from the city of New London presented information on health and safety considerations when making energy efficiency improvements, including how to access resources to address challenges that arise, such as code issues or the presence of asbestos. Thames Valley Council for Community

Action, which serves more than 20 communities in southeast Connecticut, also participated highlighting their full range of human service programs, including energy assistance.

The workshops demonstrated that Connecticut homeowners have numerous options when it comes to conserving energy as a path to lower energy bills. Fortunately, low and moderate income households are not excluded from many of these opportunities. "The challenge for many is how to navigate the myriad of services and programs that are available," said Operation Fuel's Executive Director Karen Adamson. "That's one of the barriers that these workshops are designed to knock down. The service providers presenting at these workshops are experts at maximizing available resources and the impact for the homeowner, both in terms of conservation and cost savings," she added.

As a result of the workshops, almost every participant has requested an energy audit or an analysis of the feasibility of solar panels for their home (or both). Based on the success of the workshops held in New London, Operation Fuel will be seeking opportunities to replicate the event in more communities throughout the state.
