Over 320,000 Connecticut Households Are Struggling to Pay Energy Bills



More than 320,000 lower- and moderate-income Connecticut families and individuals are struggling with unaffordable energy bills. These households, which have incomes at or below 200 percent of the Federal Poverty Level, owe a combined \$450 million more in annual home energy bills than they can afford to pay, according to the Home Energy Affordability Gap: Connecticut (2017) report, which Operation Fuel released in December.

The \$450 million home energy affordability gap is the portion of their energy bills that more than 320,000 Connecticut households can't afford to pay, not the entire amount that they owe. On average, each household owes \$1,404 more in annual energy bills than they can afford.

For more than 40 years, Operation Fuel has worked with its community and business partners to help struggling families and individuals who can't afford their energy bills. Since raising its income guidelines to 75% of the state median income, Operation Fuel has seen an increase in energy assistance applications from moderate-income households that are in financial crisis.

Through late February, Operation Fuel had provided nearly \$720,000 in winter

energy assistance to 1,650 households throughout Connecticut. About half of all the people helped are either children or elderly. Operation Fuel will continue to provide winter and spring energy assistance until May 31.

During the spring and summer months, some lower-income families and individuals are in danger of having their utility services terminated because they do not have the resources to keep up with the high cost of energy. The annual winter moratorium, which prevents eligible households from having their utilities shut off, ends on May 1 and won't resume until November 1, 2018.

In early July, Operation Fuel will start its summer energy assistance program to help these vulnerable households that live in fear of losing their electricity or gas services.

"Being without electricity during the hot summer months can create serious problems. This situation is especially dangerous for young children, the elderly and people with chronic medical conditions. Without electricity you can't refrigerate food or medicine, cook meals or have lights and hot water," said Brenda Watson, Operation Fuel's Executive Director.

Operation Fuel and Utility Companies Host Annual Energy Assistance Conference

This past October, Operation Fuel held its annual statewide Energy Assistance Conference in partnership with Eversource Energy and Avangrid subsidiaries: United Illuminating, Southern Connecticut Gas, and Connecticut Natural Gas. The conference was attended by representatives from several state agencies and fuel banks throughout Connecticut, as well as staff from Operation Fuel and the utilities.

The energy assistance conference focused on the availability of energy assistance and the various programs offered by the utility companies to help low- and moderate-income households manage their energy expenses. The meeting also provided an opportunity for fuel bank staff to get answers to questions that they had about energy assistance and energy efficiency programs that can help to lower energy costs.

State of Connecticut Consumer Counsel, Elin Swanson Katz, was the conference's guest speaker. Based on the data her office has received, Swanson Katz said that about 25 percent of Eversource Energy and United Illuminating customers are

struggling to pay their electric bills and many of these households are sometimes unable to pay their bill in full.

"This creates tremendous burdens on their (customers) lives, in terms of the risk of shut-off, fear and uncertainty, but it also impacts the general customer base, who ultimately covers the uncollectible shortfall," said Swanson Katz.

She added that the fuel banks can help their low-income clients by urging them to read their electric bills; warning them about the increasing number of utility scams; and reporting to her office when electrical suppliers harass clients with repeated telemarketing inquiries.

Charity Navigator Gives Highest Rating to Operation Fuel

Operation Fuel was notified on March 1, 2018 that the organization once again has received the highest rating possible from Charity Navigator, which is one of the nation's leading charity evaluators. Operation Fuel received the top rating for demonstrating strong financial health and commitment to accountability and transparency. "This is our highest possible rating

and indicates that your organization adheres to sector best practices and executes its mission in a financially efficient way," said Michael Thatcher, Charity Navigator's President and CEO.

Since 1977, Operation Fuel has provided nearly \$50 million in energy assistance to over 156,000 households throughout Connecticut. This past fiscal year, over 20,000 individuals received energy assistance; almost half were either elderly or children under the age of 18.

Throughout the years, many people have played a role in Operation Fuel's mission to help struggling families and individuals keep their heat on and electricity running.

In late September, Operation Fuel observed its 40th anniversary at a reception with some of its community partners and supporters at the Riverfront Boathouse in Hartford.

New Partnership with The Tiny Miracles Foundation

As part of its mission, Operation Fuel works with other nonprofit organizations to ensure that vulnerable families are able to keep their heat and electricity running.

Operation Fuel recently began partnering with The Tiny Miracles Foundation, of Fairfield County, which helps families with premature babies by providing support, information, services and supplies for the families during and immediately following their hospital stay.

"Tiny Miracles was unaware of our services before and now they are able to refer families who are struggling financially to our energy program. These families are faced with enormous challenges just trying to focus on their newborns' health," said Brenda Watson, Operation Fuel's Executive Director.

"I'm looking forward to working with Operation Fuel to discover ways that we can jointly serve families that are in financial distress and are at risk of losing heat or electricity while caring for their fragile infants," said Elisabeth T. Schneider, who is Director of Family Services for The Tiny Miracles Foundation.

Within just a few weeks of learning about Operation Fuel, Tiny Miracles was able to refer a family to the energy assistance organization's local fuel bank. "I love that we could put it to immediate use!" added Schneider.



In 2013: Town of Darien Requested to Be a Fuel Bank

Since Darien became a fuel bank in 2013, Operation Fuel has helped local families and individuals with \$27,896 in energy assistance grants. Previously, Darien residents needed to go to the fuel bank in Norwalk.

"We advocated for Operational Fuel to give us our own fuel bank to better serve our community. It was very inconvenient for our clients, especially the seniors and people who are disabled, to travel to Norwalk," said Cynthia Hall, a Case Manager with the Darien Department of Human Services. Hall processes applications for Operation Fuel along with Darien's Director of Human Services, Ali Ramsteck, who is also the fuel bank director.

recently made a difference for an elderly Darien couple, who has lived in their home for 60 years, when they needed energy assistance. The 87 year-old wife has been working as a crossing guard for the last 35 years. But because the couple was slightly over income, they were not eligible for energy assistance

from the Connecticut Energy Assistance Program (CEAP). Fortunately, Operation Fuel was there to help.

“The (Operation Fuel) applications are simple and are processed promptly. Operation Fuel has a great team. The staff is very knowledgeable and helpful,” added Hall.

Greenwich Fuel Bank Has Longtime Partnership

For the past 20 years, the Greenwich Department of Human Services has partnered with Operation Fuel to provide energy assistance to families who are going through a financial crisis.

“Operation Fuel has very clear guidelines to assist families who are making their best effort to maintain their utility service. The staff is extremely responsive and understanding of special situations that our clients may have and makes every effort to provide assistance in a very timely manner,” said Monica Bruning, Greenwich’s Director of Human Services Programs.

Operation Fuel helped 50 Greenwich households with \$21,852 in energy assistance this past fiscal year.

Recently, Operation Fuel was able to keep a Greenwich husband and wife and their three children from losing their utility service. The husband, who is serving in the military, had been deployed and the family was struggling financially, explained Bruning, who also is the town’s fuel bank director. Thanks to Operation Fuel, the family avoided having their service terminated and was able to enroll in their utility company’s New Start program and begin making affordable monthly payments.

Another Greenwich family, with a young child, needed help after the husband was diagnosed with Parkinson’s disease and could no longer work. The Greenwich fuel bank assisted the family with an Operation Fuel energy assistance grant and helped them get on an affordable budget plan.

Bruning said her town greatly appreciates Operation Fuel. “Operation Fuel totally fits in with our organization’s mission to enhance the quality of life for Greenwich residents by meeting basic human needs and promoting services that foster self-sufficiency,” concluded Bruning.

In the Spring: Westport Needs Operation Fuel

The Westport Fuel Bank is very grateful that Operation Fuel has a year-round energy assistance program. The spring is usually when Westport residents need Operation Fuel the most.

The Fuel Bank Director, Susan Stefenson, said many Westport residents who need heating assistance are eligible for the Connecticut Energy Assistance Program (CEAP). These vulnerable households - whether they heat with oil, propane, gas or electricity - are also covered by the utility company’s Winter Protection program, added Stefenson. However, when these safeguards expire on April 30, Operation Fuel adeptly provides additional assistance.

“Operation Fuel helps us bridge that gap . . . particularly in the spring months. Households that are coming off Winter Protection in May often need additional support, which Operation Fuel provides,” explained Stefenson, who is the Finance Manager for Westport’s Department of Human Services.

She anticipates that there will be a significant number of requests for Operation Fuel grants this spring. “The bitter cold snap that passed through in January stressed many households and accelerated energy consumption. The need will become more apparent in the next few months,” said Stefenson.

Last spring, the Westport Fuel Bank helped a range of households with energy grants from Operation Fuel. Between March 1 and May 30, 2017, Operation Fuel provided \$5,444 to 11 households.

One was a senior couple who did not qualify for state and federal assistance. “Operation Fuel granted them money for heating because they recognized the need to assist households on a fixed income that are draining their savings to age in place,” said Stefenson. Another recipient was a single disabled client who was about to lose his utility service when the Winter Protection program ended. But with the help of Operation Fuel, the shut-off was averted and the client was able to stay comfortably in his home.

Stefenson said that she especially appreciates that Operation Fuel’s application process is straightforward and decisions are made quickly to accommodate emergency requests.

LifeBridge Fuel Bank: Many Clients Work But Are Still Struggling Financially

LifeBridge Community Services in Bridgeport is one of Operation Fuel's largest fuel banks in Fairfield County.

This past fiscal year, LifeBridge provided \$81,011 in Operation Fuel energy assistance grants to 182 households. Through late February, the fuel bank had helped 173 households with \$74,000 in winter energy assistance from Operation Fuel.

LifeBridge became a fuel bank two years ago after partnering with Operation Fuel on the energy assistance organization's Homeless Intervention and Prevention Program (HIPP). When LifeBridge's Eviction Prevention program lost funding, they had to drop out of HIPP but wanted to continue its partnership with Operation Fuel.

Since energy assistance is a good fit with many of their other programs and

services, LifeBridge decided to become a fuel bank. "Programs like Operation Fuel don't just pay utility bills, they allow families to be more secure and reduce some of the stress low- and middle-income families face every day," said Andrew G. Geisert, LifeBridge's Director of Economic Empowerment.

He added, "Many of our clients work but still struggle to pay their bills and maintain financial stability, which is essential for family stability."

Sam is among the many clients who have been helped by Operation Fuel. The 84 year-old man, who lives alone, owns his home and must cover all his expenses with his Social Security retirement benefit of \$767 a month. His daughter helps him when possible but isn't financially able to provide regular support. For the past two years, Sam has received Operation Fuel energy assistance, which helps him keep up with his bills but more importantly allows him to stay in his home where he feels comfortable.

"LifeBridge understands that people impacted by poverty are challenged by a range of complex social, economic, and health issues. Our goal is to move our clients from crisis to stability, and to greater levels of self-sufficiency. Operation Fuel energy assistance is critical to providing the stability our clients need to advance themselves and their families," said Geisert.

Credit Unions Support Operation Fuel's Homeless Intervention & Prevention Program

The Connecticut Credit Union Charitable Foundation provided a very generous \$10,000 grant to Operation



Fuel in December to support the Homeless Intervention and Prevention Program (HIPP). The grant represents funds from Connecticut's Credit Unions, which contribute to various causes around the state every year and work together to raise funds.

A charitable golf tournament fundraiser and a raffle are held annually where credit unions sell tickets to their members for the chance to win some great prizes. The Connecticut Credit Union Charitable Foundation uses the funds raised to help various food and fuel organizations around the state. Operation Fuel was grateful to be one of the fortunate recipients in 2017.

Operation Fuel started the Homeless Intervention and Prevention Program in 2013 to help prevent and eliminate homelessness that occurs as a result of unaffordable home energy costs. HIPP provides energy assistance grants to people who are homeless or at risk of becoming homeless and need to pay past due energy/utility bills to either stay in their home or transition from homelessness to permanent housing. Since it began, HIPP has provided \$166,978 in energy assistance to 258 Connecticut households and made it possible for 634 people to either resume or maintain housing.

We are in further talks with the Connecticut Credit Union Charitable Foundation to collaborate on ways to partner together, including offering financial training from the Credit Unions for our HIPP clients at fuel bank sites.

"We are immensely grateful to Connecticut's Credit Unions for their significant donation for our Homeless Intervention and Prevention Program. We will be able to serve many vulnerable families in need of our services and in danger of losing their homes," said Kim O'Brien Green, Operation Fuel's Director of Development.

"Connecticut's Credit Unions are extremely excited to partner with Operation Fuel in the spirit of cooperation and people helping people," said David Hinchey, Director of Community Impact for the Credit Union League of Connecticut. "By collaborating, both our organizations can create a greater impact on the communities we serve."


