New Law Will Save Money for Low-Income Electricity Customers



A big win first spearheaded by Patricia Wrice, former Executive Director.

In 2008, Patricia Wrice, former Executive Director at Operation Fuel began the implementation of a discount for low-income electric customers, shortly after she initiated the state's first ever energy affordability gap study. The low-income discount rate was introduced in the 2010 legislative session as a policy initiative but did not successfully become law. In October 2019, PURA initiated an investigation into the affordability of energy, which played a pivotal role in shaping the framework for furthering discussions on affordability within the state. In October 2022, PURA announced its final decision in the investigation into a discounted utility program. During our interview, Patricia stated, "I'm so happy the organization didn't let it drop and continued to press forward". The two-tiered discount rate will begin no later than January 1, 2024. Households with incomes at or below 60% of the state median can receive a 10% discount off their total electric bill each month and households earning up to 160% of the federal poverty guidelines (FPG) are eligible to receive a 50% discount off their electric bill each month. This is a huge win and a step in the right direction in creating energy affordability for residents of Connecticut.

This year, Operation Fuel acted as safety net for more than 10,000 Connecticut households to stop disconnection from electricity, water, or gas and keeping households from crisis.

Requests for utility assistance have more than doubled, matching the growing crisis across the country. According to the National Energy Assistance Directors Association, as of March nearly 20 million US households are behind on their utility payments, an increase of more than 3 million compared to just last year.

Many, like Connecticut resident Lori, find themselves struggling for the first time. "This has been so hard. I've never had to ask for assistance before. I cannot thank you enough, and I will be sure to pay it forward once we are back on our feet."

Every day, we encounter individuals and families who are caught in a relentless cycle of financial hardship, unable to find a way out. Families like Shanea from Stratford, a single mother who was hospitalized for two months, leaving her with no income to support herself and her two daughters. "This has been the hardest year of my life." She said, "The approval for assistance was a great help and blessing for myself and my daughters."
