

Home Energy

Bridgeport Heat Pump Workshops and Webinars

Operation Fuel partnered with Energize Connecticut and Greater Bridgeport Community Enterprises – The Green Team. Together, we led workshops tailored to low-and-moderate-income homeowners to learn how heat pumps can enhance home comfort and reduce energy costs. Participants gained insights into installation, heating and cooling benefits, and available incentives to make their homes more energy-efficient and eco-friendly.

Climate Smart Technology



Operation Fuel is proud to be a collaborator on the study, "Emerging Health Needs for Climate Smart Technology in Connecticut Affordable Housing." Our findings show the vital need for support systems that ensure the safety and well-being of our most vulnerable populations, especially those reliant on home medical devices.

Advocacy

Operation Fuel Weighs in at PURA

Public Utilities Regulatory Authority (PURA) is a quasi-judicial agency responsible for interpreting and enforcing the statutes and regulations that shape Connecticut's utility sector. Since May 2024, Operation Fuel has blazed a trail by actively participating in the Stakeholder Group Compensation Program, leveraging our platform to advocate for equitable energy policies. By providing informed commentary during PURA's public proceedings, we amplify the voices of Connecticut residents in need, promoting greater accountability and access in the utility system.

Advocacy at the State Capitol

Operation Fuel has been a steadfast presence at the Capitol, championing policies that prioritize the needs of Connecticut residents facing energy insecurity. Our advocacy efforts included:

- Earning unanimous support from the CT General Assembly to secure \$1.75 million in February 2024, to extend our winter assistance season for another month. This critical funding allowed us to provide support to an additional 3,300 households this winter, demonstrating the tangible impact of strong, consistent financial support.
- Fighting against proposed legislation that would have placed additional barriers on low-income ratepayers seeking medical protection from utility shutoffs, ensuring vulnerable residents retain access to essential utilities.
- Supporting legislation that would have expanded access to heat pumps for Connecticut residents, by leveraging federal funds. Operation Fuel will continue advancing equitable solutions for clean and affordable energy.






